Family Centered Treatment Foundation, Inc. ("Family Centered Treatment Foundation") operates familycenteredtreatment.org. It is Family Centered Treatment Foundation's policy to respect your privacy regarding any information we may collect while operating our website.

Website Visitors

Like most website operators, Family Centered Treatment Foundation collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request.

Family Centered Treatment Foundation also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments.

Gathering of Personally-Identifying Information

Certain visitors to Family Centered Treatment Foundation 's website choose to interact with Family Centered Treatment Foundation in ways that require Family Centered Treatment Foundation to gather personally-identifying information. The amount and type of information that Family Centered Treatment Foundation gathers depends on the nature of the interaction. Those who engage in transactions with Family Centered Treatment Foundation are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Family Centered Treatment Foundation collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Family Centered Treatment Foundation. Family Centered Treatment Foundation does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Protection of Certain Personally-Identifying Information

Family Centered Treatment Foundation discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Family Centered Treatment Foundation's behalf or to provide services available at Family Centered Treatment Foundation's website, and (ii) that have agreed not to disclose it to others. Family Centered Treatment Foundation's will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Family Centered Treatment Foundation discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Family Centered Treatment Foundation believes in good faith that disclosure is reasonably necessary to protect the property or rights of Family Centered Treatment Foundation, third parties or the public at large. Family Centered Treatment Foundation takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Family Centered Treatment Foundation uses cookies to help Family Centered Treatment Foundation identify and track visitors, their usage of Family Centered Treatment Foundation website, and their website access preferences. Family Centered Treatment Foundation visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Family Centered Treatment Foundation's website, with the drawback that certain features of Family Centered Treatment Foundation's website may not function properly without the aid of cookies.

Business Transfers

If Family Centered Treatment Foundation, or substantially all of its assets were acquired, or in the unlikely event that Family Centered Treatment Foundation goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Family Centered Treatment Foundation may continue to use your personal information as set forth in this policy.
